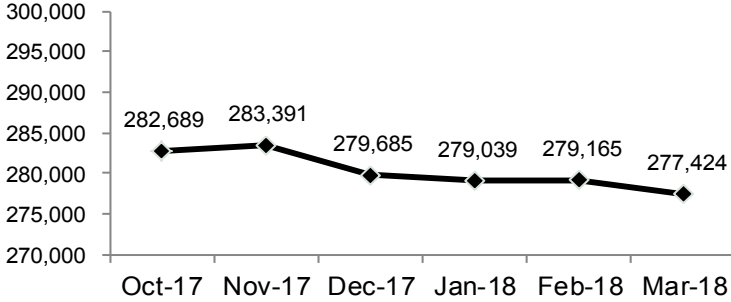

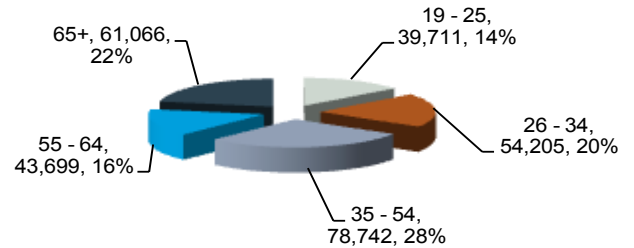

Mar-18 Enrollment: 277,424 Mar-17 Enrollment: 285,384 Change in Enrollment: -7,960

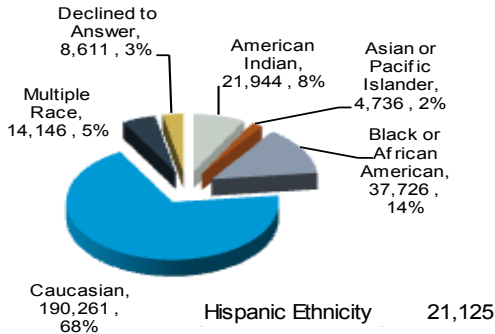
Age Breakdown of Adult Enrollment
