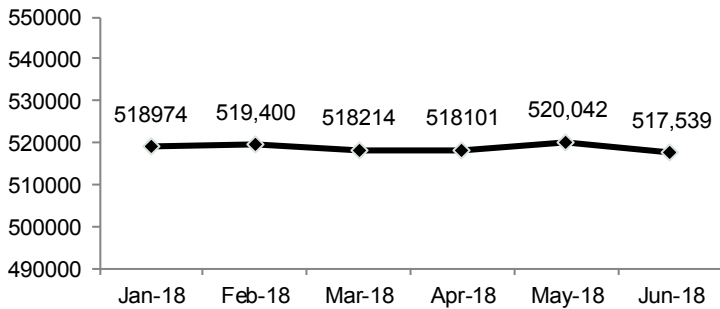

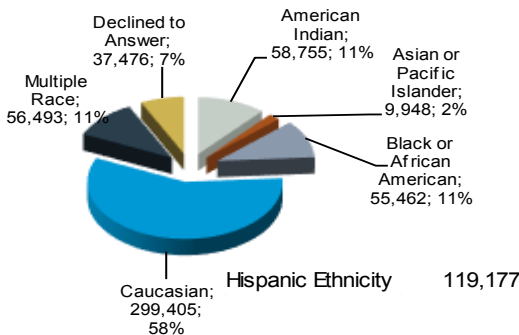
SFY2018 Enrollment Year to Date 607,295

Jun-18 Enrollment: 517,539 Jun-17 Enrollment: 529,160 Change in Enrollment: -11,621

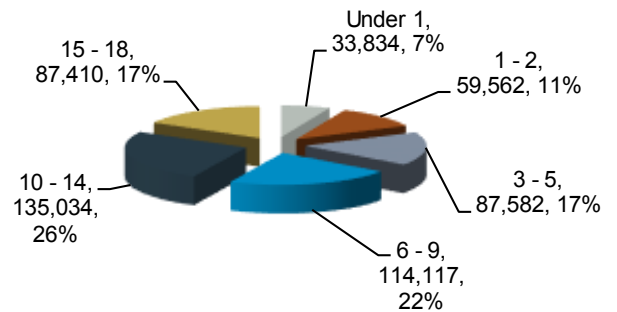
Race Breakdown of Child Enrollment
